Program 1:

Description: The American Cancer Society Road to Recovery program provides transportation to and from treatment for people who have cancer and do not have a ride or are unable to drive themselves. Volunteer drivers donate their time and the use of their cars so that patients can receive the life-saving treatments they need.

Program 2:

Description: American Cancer Society Reach to Recovery program has helped people (female and male) cope with their breast cancer experience. Reach to Recovery volunteers offer understanding, support, and hope because they themselves have survived breast cancer and gone on to live normal, productive lives. Talking with a specially trained Reach to Recovery volunteer at this time can give a measure of comfort and an opportunity for emotional grounding and informed decision-making

Program 3:

Description: The Look Good...Feel Better program is a community-based, free, national service. It teaches female cancer patients beauty tips to look better and feel good about how they look during chemotherapy and radiation treatments. The Look Good...Feel Better program was founded and developed in 1989 by the Personal Care Products Council (at the time called the Cosmetic, Toiletry and Fragrance Association, or CTFA), a charitable organization supported by the cosmetic industry, in cooperation with your American Cancer Society (ACS) and the National Cosmetology Association (NCA). Volunteer beauty professionals lead small groups, usually about 6 to 10 women, through practical, hands-on experience. Women learn about makeup, skin care, nail care, and ways to deal with hair loss such as with wigs, turbans, and scarves. Each woman gets a free makeup kit to use during and after the workshop. The self-help materials include a 30-minute video entitled *Just for You: A Step-by-Step Guide to Help You Look Good and Feel Better During Cancer Treatment*, a step-by-step instructional booklet and an evaluation form. The videotape features cancer survivors and volunteers talking about the ways cancer treatment and side effects can affect the way you look. It also covers detailed skin care information, "how to" makeup tips, wig information, nail information and pointers on head coverings. The self-help brochure is for men who are getting chemotherapy or radiation treatment. It gives them information on how to deal with the way treatment and side effects can change the way they look, as well as other information that is useful during this challenging time.

Program 4:

Description: I Can Cope program is an educational program for people facing cancer – either personally, or as a friend or family caregiver. I Can Cope classes can help dispel cancer myths by presenting straightforward information and answers to your cancer-related questions about: diagnosis and treatment, side effects of treatment, self-esteem and intimacy, communicating concerns and feelings, community resources, financial concerns, pain management, nutrition and physical activity, cancer-related fatigue, and keeping well in mind, body, and spirit. There is no charge for attending I Can Cope classes. You do not need a physician's referral, but for

planning purposes pre-registration may be required. I Can Cope classes are also available online. I Can Cope online classes are self-paced and you can take them in the privacy of your home or location of your choice at a time that is convenient for you. Description: Beautiful Lengths is a wig bank which offers new free wigs to women through Pantene pro-v. Donations are accepted but women's hair must be 8 inches or longer. If interested, please go to www.beautifullengths.com for more information.

Program 2:

Description: The boy's family is required to participate in evaluations which are held on campus. There are also home visits which keeps the families up to date on the process for their children. The camper returns home every 6 weeks for four days. The home visit allows the camper to apply the skills he learned at camp toward his family members. The counselors can measure the boys progress through home visits.

Program 3:

Description: Academics are built into the daily routines and activities. Each camper is taught to use practical mathematics in the designing and construction of the tents. Weekly meal planning and cooking provides opportunity to learn about nutrition, budgeting, and home economics. Each week, campers visit the Trading Post, the Wilderness Camp store where they learn to write checks and keep checking accounts. When the group plans the weekly schedule, a boy is required to cooperate creatively with others, and put his thoughts into words on paper.

The Central Intermediate Unit # 10 Preschool Early Intervention Program is a year- round system that identifies and provides Early Intervention Special Education services to eligible young children who must meet the following criteria: (1) Age three to five years old and not yet enrolled in kindergarten

(2) Reside in Clinton, Centre or Clearfield County and are (3) Exhibiting a developmental delay of at least 25% and/or a diagnosed disability and are in need of Specially Designed Instruction.

The process of determining if a child has a developmental delay usually begins at the screening level. If the child does not pass the screening activities or if there is supporting documentation of a disability, the multidisciplinary team (usually a teacher and speech therapist) will recommend moving directly to an evaluation. The family is our most important source of information and no assessment is conducted without the family's written consent. Programs and services for children who are eligible for Early Intervention are determined by a team of professionals and the child's family who develop an Individualized Education Plan (IEP) which includes goals for working on skills in those areas, such as cognitive, motor, communication, self-help or social, where the child is not yet demonstrating age appropriate development. Preschool Early Intervention services for eligible young children are provided at no cost to the family. These services may include (1) Itinerant Special Education Instruction or Therapy provided by a Teacher and/or Therapist at a Child's Home, Preschool, Childcare site, or Head Start class (2) Speech and Language Therapy (3) Classroom-based

services – Integrated or Specialized (4) Teacher of the Hearing Impaired or the Visually Impaired (5) Occupational or Physical Therapy (6) Assistive Technology and (7) Psychological services.

Referral process: Children may be referred by anyone who is involved in the child's life, however, no further action will be taken until the family has been contacted and has agreed to proceed with the referral for their child.

Service 6: Home Support Cleaning Service is provided when the need is for light housekeeping tasks, laundry, shopping, or instruction in home management or basic cooking skills.

Service 7: Home Modification and Repair provides home maintenance repairs and modifications necessary to maintain the individual’s safety in the home, such as, ramps, railings, grab bars, etc.

Service 8: Home Health Services are usually covered by Medicare or other insurance under orders of a physician. In special circumstances, physician ordered services may be provided by the Office of Aging to enable an individual to continue to reside in his or her own home. Twenty-four hour care is not available.

Service 9: Personal Care Services are provided when the primary need is for “hands-on” assistance with the activities of daily living.

Service 10: The Family Caregiver Support Program is designed to respond to the needs of families and friends caring for their loved ones at home. Its purpose is to reinforce (not replace) the care being provided to the older person (who requires daily care) at home.

Service 11: The objective of the Nursing Home “Waiver Program” is to provide care in the community for individuals who would otherwise be eligible for nursing home care.

Service 12: The Nursing Home Transition (NHT) program assists eligible nursing home residents who wish to safely return to the community and to a more independent lifestyle, with the assistance of Aging Services. NHT is available to anyone over 18, and of any income level. The Office of Aging will directly assist individuals over 60 and they will provide referral assistance to anyone under 60.

Service 13: Placement Services are designed to assist the individual in determining the type of residential placement that will best meet their needs. The Office of Aging will assist them in securing such placement (Nursing Homes, Assisted Living Facilities, and Personal Care Homes).

Service 14: An Ombudsman is a person trained and certified by the Pennsylvania Department of Aging in the investigation and resolution of complaints made by, or on behalf of, consumers of long term care services. Ombudsmen help consumers voice concerns and exercise their rights, in order to protect the dignity, well-being, and quality of life for individuals age 60 and over, in various care settings.

Description: Homecare services may include skilled nursing care, home health aide, occupational therapy, physical therapy, speech therapy, and social work consults. Skilled nursing care is provided by licensed professional nurses and includes comprehensive nursing assessments as well as specialized care including hematology, oncology, Infusion Therapy, enterostomal therapy, pediatrics, cardiovascular care, psychiatric/mental health, diabetes care, restorative nursing, and maternal child care.
